#### **3 Group Activities**

Despite not being able to hold a fete during the year, the Society nevertheless decided to provide hanging baskets for the village, however, the allotment group sold its produce at the Farmers Market and at the Pop-up shop outside the post office thus contributing some £1070 towards our funds.

Our Volunteers continue to maintain our allotment at St Michaels Allotment. to provide plants for our hanging baskets and weekly watering using our Bowser our thanks to them and the contribution from Snooks Corner Community Group towards the total costs

We also continue to work with the Felpham Parish Council to renovate the whole allotment site with many of our volunteers . and are due to receive this April a grant of £1000 towards our hanging basket costs and our work for the community.
